- DATES:** 26 November (Saturday), 2022
- LOCATION:** Tri-County Gun Club, Sherwood, Oregon 97132
- SANCTIONED BY:** Civilian Marksmanship Program, P.O. Box 5761, Port Clinton, Ohio 43452
- ELIGIBILITY:** The match is open to individuals of all ages, provided each competitor complies with *CMP Smallbore Rifle Competition Rules* eligibility requirements (3.0 Eligibility to Complete). Namely, competitors must have a notarized eligibility affidavit and a signed waiver of liability agreement on file with Tri-County Gun Club.

- ENTRY FEES:** \$10.00 per competitor. Make checks payable to **TCGC**.
- RULES:** The match will be governed by *CMP Smallbore Competition Rules*. Copies of the rules may be downloaded from the CMP website at:

- CMP Rules require the insertion of a Clear Barrel Indicator (CBI) in all rifles, at all times, on ranges where sanctioned events are conducted, except when rifles are on the firing line during preparation and firing periods.
- COURSE OF FIRE AND TIMING:** Smallbore: 15 minutes preparation/sighting period followed by 1 hour and 30 minutes for 60 total record shots (integer). Competitors must fire 20 record shots for each position in order: Kneeling – Prone – Standing. After competitors complete kneeling and prone positions, unlimited Sighting shots for the next position are allowed. Standard ISSF Rifle Rules 7.7.1, 7.7.3 (Rifle Events) apply.
- At the completion of each relay, competitors will be afforded 5 minutes to remove their equipment and to evacuate the line. There will be a 5 minute call to line period for the incoming relay. This time will also be used for the range staff to reset the range.
- DISTANCE:** Smallbore: 50 ft

TARGETS: Megalink Electronic Scoring System targets:  
Smallbore: no. 1295

COACHING: Verbal coaching will **not** be permitted on the firing line. Non-verbal is permitted.

SCORING AND PROTESTS: Scoring is inherent with the Megalink targets. Results will be final 15 minutes after the completion of each respective relay. Ties will be broken in accordance with CMP rules. Juries will be appointed and convened to resolve any protest. Decisions of the jury will be final. Live scoring will be available at <http://results.megalink.no> via the Tri-County Gun Club link.

ENTRY, SQUADDING, AND SCORE SUBMISSION: Intent to participate in the event is requested via the program Entry Contact. Please indicate with registration which relay you would *prefer* to fire. We will try to honor squadding requests, but relays will be filled in order entries are received. Scorecards will be submitted along with a completed *CMP Sanctioned Match or Clinic Report* to CMP within seven days following the match.

ENTRIES CLOSE: Every effort will be made to accept all competitors who enter. To ensure range capacity, contact the Entry Contact at the top of this program no later than November 18, 2022 to secure placement in the desired events.

Relay 2 – 1055 call to line; 1100-1115 Prep/Sighting; 1115-1245 Record Fire

AWARDS AND ACHIEVEMENT Metals awarded to overall first, second, and third place finishers. CMP Achievement Pins will be awarded based on 2022 Smallbore Rifle Achievement Award Cut Scores: Gold pin for  $\geq 558.0$ , silver pin for 540-557, and a bronze pin for 525-539.

WAIVER OF LIABILITY: Competitors are required to sign a Tri-County Gun Club Waiver of Liability (ages 18 and older) or provide a signed [Junior Release Form](#) (ages 17 and younger) upon entry to the range. An addendum for CMP sanctioned competitions must also be signed.

- Head south on I-5 S
- Take exit 286 to merge onto OR-141/SW Boones Ferry Rd (0.3 mi)
- Merge onto OR-141/SW Boones Ferry Rd (0.3 mi)
- Use the left 2 lanes to turn left onto SW Day Rd (0.6 mi)
- Turn right onto SW Grahams Ferry Rd (0.4 mi)
- Turn left onto Basalt Creek Pkwy (0.7 mi)
- Turn left onto SW Tonquin Rd (1.0 mi)
- Turn right at Tri-County Gun Club (0.3 mi)

From I-5 S

- Head north on I-5 N
- Take exit 286 toward Stafford/N Wilsonville (0.3 mi)
- Use the left lane to keep left at the fork and follow signs for Boones Ferry Rd (108 ft)
- Turn left onto SW Elligsen Rd (0.2 mi)
- Continue onto OR-141/SW Boones Ferry Rd (0.3 mi)
- Use the left 2 lanes to turn left onto SW Day Rd (0.6 mi)
- Turn right onto SW Grahams Ferry Rd (0.4 mi)
- Turn left onto Basalt Creek Pkwy (0.7 mi)
- Turn left onto SW Tonquin Rd (1.0 mi)
- Turn right at Tri-County Gun Club (0.3 mi)
