Eligibility:     Although current membership in the National Rifle Association of America (NRA) is not required, preference will be given to individual members of the NRA if there is an excess of walk-ins. Junior competitors may be individual members of the NRA, or members of an NRA Affiliated Junior Rifle Club.

Entry Fee:      \$10.50 per championship + \$5.50 NRA + \$3 OSSA fees per entrant. Please bring a check payable to Tri-County Gun Club for exact funds to help move things along.

On-Site Entry:   0900-0945 for the first match each day. 1300-1320 for the Saturday Hunter Rifle match. Entrant will provide current NRA classification and NRA member number (as appropriate). Proof to be shown on the day of the matches. Scoped rifle matches are limited to 2 relays and 16 shooters. Cowboy rifle match is limited to 3 relays and 24 shooters. To date, we have been able to accommodate "walk ins". However, advance registration is appreciated, to reduce paperwork, and help in planning.

Entries Close:   At end of sign-ups for the match, or when range capacity is met.

Rules:           Current NRA Rifle Silhouette rules will govern unless stated otherwise.

Open Bolt Indicator: Required. Available for a nominal fee.

Sighters:        Five minutes prior to the start of the match.

Course of Fire:   Rule 7.2 Scoped rifle matches are 40 shots each. One-fifth size standard High Power Rifle Silhouette targets. Ten chicken targets at 40 meters, ten pig targets at 60 meters, ten turkey targets at 77 meters, and ten ram targets at 100 meters. Rule 8.2(b) Two and one-half minutes to fire one shot at each target of a bank of five targets.

Cowboy rifle championship is 2 matches of 40 shots each, plus aggregate. Rule 7.4(c) Smallbore Cowboy Rifle. One-half size standard High Power Rifle Silhouette targets. Rule 7.4.2 Ten chicken targets at 40 meters, ten pig targets at 50 meters, ten turkey targets at 75 meters, and ten ram targets at 100 meters. Rule 8.2.2(b) Two minutes to fire one shot at each target of a bank of five targets.

Awards: Champion's Plaque to the winner of each event (cowboy aggregate winner) \*.  
2<sup>nd</sup> Place Plaque if there are more than 10 entrants in an event \* \*\*.  
Tri-County Gun Club Silhouette mug to the winner of each cowboy match, the cowboy aggregate, plus each class in the scope rifle and cowboy aggregate events\*\*\*.  
Cash prizes for each class dependent upon turnout – see below.

\* To be eligible for awards, an Oregon resident must be a current member of the Oregon State Shooting Association; Oregon non-residents must be a member of either the Oregon State Shooting Association or the state association of their state of residence. OSSA memberships will be available for purchase during sign-up.

\*\* Due to highly variable turnout, 2<sup>nd</sup> place plaques may be ordered and sent to the recipient after the match.

\*\*\* Rule 19.8 Classes with 1 or 2 entrants will compete in the next higher class.

Note that many shooters who usually attend our matches prefer to shoot for “applause” more than prizes, so the entry fees and prizes are kept simple to encourage a good turnout.

If there is a large turnout, additional cash prizes will be awarded so that 100% of the entry fees, minus NRA fees, OSSA fees, and expenses are returned to the shooters in the form of prizes and awards. Tri-County Gun Club is a nonprofit organization, and will not make a profit on these events.

#### General Information:

Shooters will help set up the range, reset targets, take down the range at the end of the day, and spot/score for shooters on alternate relays. If you are unable to do so, please bring your own spotter/setter or arrange for a fellow competitor to cover for you prior to the start of the match.

Water is available at the clubhouse. August is often warm to hot, so best to bring plenty.

The firing line is covered/shaded, but open on all 4 sides. Benches are available for sighters, and to hold your gear while shooting. Shaded, covered space is available behind the firing line if you are not shooting or spotting.

Food is available for lunch approximately 10 minutes away. However, that may not leave much time for lunch if the morning session runs long, so bringing a “brown bag” may be a better option.

Spotters may need to wear masks, depending upon state regulations at that time.
